

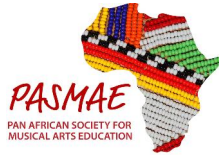


Call for Nominations to the Pasmae Executive Committee, 2019 – 2021

The Nominating Committee is looking for committed candidates to offer strong leadership and insight in pursuing Pasmae's goals. Executive Committee members are expected to participate in all Pasmae events and activities as well as participate in committee work of the Society. The Nominating Committee seeks qualified candidates to put their names forward for nomination with a view of aspiring to an Executive Committee that is reflective of the membership it serves. The Pasmae Executive Committee oversees regular and special conferences; issues such publications as may be deemed necessary; establishes and/or recommends to the General Assembly the establishment of Special Committees and/or the appointments of special functionaries as appropriate for carrying out the work of the Society; it acts on behalf of the Society on all matters of relating with governments, other organizations, institutions and persons; and lastly, it organizes at least one statutory meeting per biennium to authorize such other activities as may be appropriate to achieve the purpose of the Society.

Conditions for nominations

1. To be eligible, one must have been a paid up member for a minimum of two years, attended at least two Pasmae conferences within the past four years and ideally, but not necessarily, served as a Pasmae sub-committee member and in such capacity have contributed harmoniously, collaboratively and effectively to that sub-committee. *(Any officer proving not active, and not communicating for a period of three months, shall be substituted).*
1. The nomination must be supported by a Pasmae member(s) in good standing.
2. All nominees must sign the attached **Nomination Form A1** indicating their willingness to stand for nomination.
3. Newly elected Executive Committee members shall assume office at the close of the General Assembly, at the Seychelles 2019 conference following their election.
4. The Current Executive Committee comprises of the following members who are all eligible for re-election except the President and President Elect. They are: *Past President, President, President Elect, Vice-President Southern Africa Region, Vice-President Western Africa Region, Vice-President Eastern Africa Region.*
5. Nominees must submit a biographical paragraph detailing their suitability as a Executive Committee (not more than 150 word)
6. Executive Committee members receive no remuneration and are expected to attend one conference per year at their own expense. If need be.
7. Executive Committee members must be available to attend meetings held by the Executive Committee each year and participate in conference calls as required.
8. Nominations will be accepted by the Nominations Committee up to 2 July 2019 midnight.
